Re: Trip to New York – Monday 1st April to Saturday 6th April 2024

I am thrilled to be able to offer the exciting news that The Arnewood School will be running another residential trip to New York! We will be staying at the Holiday Inn Express Midtown, which is right next to Times Square and means we will have the opportunity to explore all of New York's exciting landmarks, points of interest, shops and theatres!

Arnewood does New York Monday 1st April to Saturday 6th April 2024

This is an amazing opportunity to experience the Big Apple and visit some of the most famous landmarks in the world including the statue of Liberty and the Empire State building as well as getting to see a Broadway show! The trip will be 6 days, with 4 full days in New York!

The cost of the trip will be between **£1800 to £1950**, flight prices have yet to be released so we are unable to give a definite price at this stage. As detailed below, all activities are included in the price and the only thing left to pay for, would be spending money and lunches.

The trip will only be open to students who are in Year 11 and Sixth Form commencing September 2023. Please complete the reply slip below and return it to the finance office, along with a deposit of £190 by Friday 10th March 2023. Once the school has made the deposit payment to the tour operator, you should be aware that the deposits become non-refundable. Cheques should be made payable to The Arnewood School with the student's name, tutor group and event on the reverse. If you have any further or urgent queries, please do not hesitate to contact me.

Please note, the remaining balance should be paid by standing order of £190 by the 10th of each month from the period of April 2023 to December 2023. A standing order mandate will be given to you once your deposit has been paid. Failure to meet each deadline will result in the student being removed from the trip.

The trip was an amazing success in 2019 and we are excited to be able to take a new cohort of students to experience the excitement of New York!
